

**RESOLUTION 21-38  
OF THE BOARD OF DIRECTORS OF HELIX WATER DISTRICT  
SUPPORTING THE NOMINATION OF PAMELA TOBIN  
AS A CANDIDATE FOR THE OFFICE OF  
ASSOCIATION OF CALIFORNIA WATER AGENCIES PRESIDENT**

**WHEREAS**, the Association of California Water Agencies has announced that a nominating committee has been formed to develop a slate for the election of its statewide officer positions of president and vice president; and

**WHEREAS**, the individual who fills the ACWA president position needs to possess a working knowledge of water industry issues and concerns, strength of character and leadership capabilities, and experience in matters related to the performance of the duties of the office; and

**WHEREAS**, this person must be able to provide the dedication of time and energy to effectively serve in this capacity; and

**WHEREAS**, Helix Water District Board of Directors recognizes that Pamela Tobin currently serves as the ACWA vice president, on the ACWA Joint Powers Insurance Authority Board of Directors, Executive and Liability Program Committees; and

**WHEREAS**, prior to her service as ACWA vice president, Pamela Tobin has served in a leadership role as a member of the ACWA Board of Directors. She has also served on the ACWA Region 4 Board of Directors since 2016 including as chair, and has served on ACWA Federal Affairs Committee, ACWA Local Government Committee and ACWA Strategic Planning Steering Committee; and

**WHEREAS**, Pamela Tobin has served in leadership roles as a member of the San Juan Water District Board of Directors since 2004, and served multiple terms as chair on the Sacramento Groundwater Authority Board of Directors and Regional Water Authority Board of Directors; and

**WHEREAS**, the Helix Water District Board of Directors believes that Pamela Tobin possesses the qualities needed to fulfill the duties of the office of ACWA president.


**NOW, THEREFORE, BE IT RESOLVED** that the Helix Water District Board of Directors does hereby support the nomination of Pamela Tobin as a candidate for the office of Association of California Water Agencies president.




